  - The sanctioned amount is debatable to the major Head 3 xxv (ii) (b) - (35 Capital Assets) Development of Sports Infrastructure (XII Plan) and is valid for payment during the financial year 2014-2015 only (applicable for accounts division).
  - The amount of the grant shall be drawn by the Account Officer, SERO, UGC, Hyderabad (Drawing and Disbursing Officer), University Grants Commission on the Grants-in-aid bill and shall be disbursed to and credited to the Principal, P V K N GOVT COLLEGE VELLORE ROAD, GREAMPET CHITTOOR 517002. by him/her through Mail Transfer / Draft.
  - The Grant is subject to the Adjustment on the basis of Utilization Certificate in the prescribed Performa submitted by the College.
  - The University/College shall maintain proper accounts of the expenditure out the Grants, which shall be utilized, only on approved items of expenditure.
  - The utilization certificate to the effect that the Grant has been utilized for the purpose for which it has been sanctioned shall be furnished to the University Grants Commission as early as possible after the close of the current financial year. Balance grant will be released only on receipt of audited UC and Statement of Expenditure etc., signed by Chartered Accountant.
  - The assets acquired wholly or substantially out of University Grants Commission's Grant shall not be disposed or encumbered or utilized for the purposes other than those for which the Grant was give, without proper sanction of the University Grants Commission and should, at any time the College ceased to function, such assets shall revert to the University Grants Commission.
